I am pleased to announce that SUNY and the RF have jointly developed Best Practice resources for human and animal subject research. These resources, "<u>Research Involving Human Subjects</u>" and "<u>Animal Care and Use</u>", are products of the coordinated work of the SUNY Compliance Steering Committee established by Bill Howard, SUNY Senior Vice Chancellor and General Counsel and Secretary, and chaired by Marti Anne Ellermann, SUNY's Executive Deputy General Counsel and Mike Abbott, SUNY's University Auditor, and by the Research Compliance Workgroup chaired by Garry Sanders, RF Executive Vice President.

Ensuring the protection and welfare of living things is critical to the integrity of good science and research. SUNY as the University and the RF as the grantee institution must operate in strict compliance with all of the requirements.

These resources provide high-level guidance and identify the essential elements required for human and animal subject programs at SUNY campuses. The topics addressed include the responsibilities of the Institutional Review Board (IRB), the Institutional Animal Care and Use Committee (IACUC), and the designations of Institutional Officials for the SUNY Campus Human Research Protections Program and Animal Care and Use Program.
