

## Award Edits

### Purpose

This document describes the edits that are performed in the Research Foundation business applications when an award is created or updated.

### Award Edits

When an award is created many of the fields in the award record cannot be changed once an expenditure is posted to the award. If a change to one of these fields is necessary after expenditures are processed, a new project, task, and award has to be created, expenses transferred, and the old project, task and award has to be rescinded. The award edits are in place for new awards created on or after July 1, 2004, to ensure that certain critical fields are valid before the award is created or changed. Note: All existing awards created before July 1, 2004, are subject to "award purpose group edits" rather than "award edits." These edits are essential to ensure consistency in corporate reporting. The edits will validate the following:

- Award Purpose, sponsor\*, NACUBO, and Organization combination
- Sponsor\* and Award Type combination
- Award Purpose and Award Purpose Group

The Award Purpose code can be changed but must remain in the same award purpose group. An edit in the system validates that the new Award Purpose is in the same award purpose group as the original Award Purpose.

\* Sponsor represents the Sponsor (Agency One) classification of sponsors, which is defined in the Current Lookup Set.
