Please be aware that a position may also have a separate working title, which may be stored in the Oracle Business System off the Assignment Screen.

Position Title Chart Overview

The chart below provides the title, grade, an indicator of whether this position is exempt or nonexempt based on the FLSA duties tests, as outlined in the Exemption Status Checklist, whether or not the position is subject to the higher of the NYS minimum wage. or if the nonexempt position is subject to the NYS minimum wage.

Note: As noted in the chart below, due to the nature of the work the following position titles are exempt from the FLSA minimum or NYS minimum salary threshold for exemption and would not be placed in an N/E grade: Attorney, Senior Attorney, Senior Associate Attorney, Associate Attorney, Camp Counselor, Camp Counselor – Student, Clinical Investigator, Senior Clinical Investigator, Research Project Assistant, Project Instructional Assistant, Educator and Teacher. These positions are noted as "Exempt" in the Minimum Salary Threshold Required for Exemption column below.
