

# **Indirect Cost Controls and Calculation**

### **Purpose**

This document describes the indirect cost controls and indirect cost calculation functionality in the RF Oracle business system.

### **Background**

Oracle does not treat the budgets for direct costs and indirect costs (F and A and Agency Fees) as separate and distinct budgets. This creates the possibility that indirect costs could be used to support direct costs and vice versa. Also, under Oracle functionality when an indirect cost rate and/or base is changed, the change is effective from the day it is changed forward. The Research Foundation of SUNY has approved negotiated indirect cost rates that can change from year to year.

To address these issues, the RF developed

- indirect cost controls, which circumvent the Oracle burdening process for F and A and Agency Fees (referred to as indirect costs) and limit indirect cost to budget. The Oracle process continues to be used for fringe benefit burden.
- an IDC calculation period function, which allows for recalculation of indirect costs on prior expenditures when a rate is changed or the indirect cost budget is increased (after having been up to budget).

## **IDC Controls**

### **Purpose of Controls**

The purpose of the indirect cost controls customization is to

- · limit indirect cost charges to budget.
- prevent funds budgeted in indirect costs from being used to support direct costs.
- prevent funds budgeted in direct costs from being used to support indirect costs.
- prevent direct costs charges from failing funds checking because of insufficient indirect costs.

### **Description of IDC Controls**

The IDC controls create an encumbrance to reserve funds budgeted for indirect costs. As indirect costs are expended, the encumbrance is reduced. The indirect cost encumbrance is the difference between budget and actuals (indirect costs expended).

- The IDC calculations occur nightly creating one summary line for F and A costs or Agency Fees based on the daily total of actuals processed.
- F and A charges are applied to the category "FAC F and A Costs" or "CSO Cost Share F and A." Agency fee charges are applied to the category "AGC Agency Fees."
- IDC can be disencumbered by award or project at anytime by selecting "Yes" in the "Disencumber IDC" field in the DFF.

Note: For IDC controls to function properly, budgetary controls must be "None" on F and A costs and Agency Fees

## **Applicability**

The IDC controls apply to F and A costs and to Agency Fees. The Award Purpose defines which awards are included in the IDC controls customization process. Refer to Award Purpose in EPSS under Field Level Info for a description of Award Purpose values including whether the IDC controls apply. The IDC controls do not apply to "At Risk" awards with no budget in F and A Costs. Once an F and A budget is created, the controls are imposed.

## **Custom Burdening Exception Report**

A "Custom Burdening Exception Report" is generated as a result of the custom burdening process. The exception report indicates reasons why burdening did not process. Decentralized campus should run this report daily and make corrections as necessary. The Office for Sponsored Program Services runs the report for centralized campuses. For more information on this report, see "Custom Burdening Exception Report" in EPSS under Grants Management, Reports/Queries, GM Oracle Reports.

#### **IDC Calculation**

#### **Description of IDC Calculation**

In the RF Oracle business system, indirect costs are calculated based on burden schedule, rate, and IDC Calc Period on the award and/or task. The 'IDC Calc Period' defines the starting point for which the indirect cost rate and base apply. An override rate/base/IDC Calc Period applied at task level is only applicable for that task.

#### **IDC Calc Period**

IDC Calc Periods are .:

- L Start Date to Date calculates IDC from the start date of the award/task applying the rate and schedule currently on the award. New awards should
  - be established as 'L' to have indirect costs calculated from the start date of the award.
- M Current Month calculates IDC starting from the 1st day of the month in which the change is made using the new rate and/or schedule.
- N No IDC, IDC rate equals 0.00 (zero).

There is an edit on the field in the award DFF based on the rate entered. Award rates greater than 0.00 (zero) must have the selection of 'L' – start date to date or 'M' Current Month. Award rates equal to 0.00 (zero) must be flagged as 'N' – No IDC.

On the award, IDC Calc Period is a required field.

On the task, IDC Calc Period is an optional field.

Exception: If an award has a 0.00 indirect cost rate and a task funded by the award has an override rate, the IDC Calc Period on the task must be entered in order for indirect costs to calculate.

### **Applicability**

The IDC calculation process applies to all awards regardless of award purpose and award type.

## **Processing IDC Rate Changes**

If an indirect cost rate changes for an award or task, the IDC Calc Period must be updated to indicate the period for which indirect cost should be recalculated. Refer to "IDC Rate Change Scenarios" in this document for examples of the process for various indirect cost changes.

To overcharge indirect cost and have it excluded from the IDC calculation and controls, the category of 'FAC Override Manual F and A' or 'AGC Override Manual Agency Fees' or 'CSO Override Cost Share F and A' must be used. Refer to scenario number 8 in the IDC Rate Change Scenarios section of this document.

# **IDC History Report**

The "IDC History Report" is available to view the history of changes entered on the indirect cost rate, base, or period type field. This report can be run as needed. For a report description refer to IDC History Report in EPSS under Reports/Queries, Grants Management, GM Oracle Reports.

## **IDC Rate Change Scenarios**

The following table provides examples of how indirect cost changes would be processed in various situations:

You would typically only do this when you want to: overcharge IDC decrease IDC, OR use the available direct cost and charge the IDC budget. |
